

NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER
HIGHWAYS ACT 1980
LINCOLNSHIRE COUNTY COUNCIL
CREATION OF PUBLIC FOOTPATH
NO'S 1092 AND 1093 TALLINGTON
PUBLIC PATH CREATION ORDER 2014

On 16 October 2024 the Secretary of State for Environment, Food and Rural Affairs confirmed the above-named Order. The effect of the Order as confirmed is to create the following public footpaths in the parish of Tallington:

A public footpath in the parish of Tallington to be known as Public Footpath No. 1092 and to be 2 metres in width running from Main Road, Tallington on Network Rail land from Ordnance Survey Grid Reference TF 0954 0853 (I) in a generally south easterly direction for approximately 92 metres to a pinch point 1.2 metres wide at Ordnance Survey Grid Reference TF 0961 0847 (J) then continuing at a width of 2 metres in a generally south easterly direction for approximately 121 metres where the route leaves Network Rail land to enter the adjacent field at Ordnance Survey Grid Reference TF 0971 0841 (B) then continuing in a generally south easterly direction for approximately 187 metres to Ordnance Survey Grid Reference TF 0986 0830 (K) then running in a generally south westerly direction for approximately 273 metres to meet with Mill Lane, Tallington at Ordnance Survey Grid Reference TF 0965 0812 (E). The total length of footpath to be added to be approximately 673 metres as shown between points I – J – B – K - E on order plan numbered 2012/009/PPO299/A3.

A public footpath in the parish of Tallington to be known as Public Footpath No. 1092 and to be 2 metres in width running from the unaffected part of Public Footpath No. 1 at Ordnance Survey Grid Reference TF 0970 0837 (A) in a generally north easterly direction for approximately 36 metres to terminate at Ordnance Survey Grid Reference TF 0973 0839 (L). The total length of footpath to be added to be approximately 36 metres as shown between points A – L on order plan numbered 2012/009/PPO299/A3.

A public footpath in the parish of Tallington to be known as Public Footpath No. 1093 and to be 2 metres in width commencing at Public Footpath No. 2 at Ordnance Survey Grid Reference TF 0975 0846 (D) and curving in a generally south then south easterly direction to follow the field boundary for approximately 349 metres to terminate at Ordnance Survey Grid Reference TF 1000 0824 (H). The total length of footpath to be added to be approximately 349 metres as shown between points D – H on order plan numbered 2012/009/PPO299/A3.

Limitations and Conditions – 4 No. Handgates to be provided at Ordnance Survey Grid References TF 0954 0853, TF 0973 0839, TF 0965 0812 and TF 0990 0834.



The Order comes into force as from 13 November 2024 but if a person aggrieved by the Order desires to question its validity, or of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within six weeks from 8 November 2024 make an application to the High Court.
