

NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER
HIGHWAYS ACT 1980
LINCOLNSHIRE COUNTY COUNCIL
PART OF PUBLIC FOOTPATH NUMBER 2 TALLINGTON
PUBLIC PATH DIVERSION ORDER 2014

On 16 October 2024 the Secretary of State for Environment, Food and Rural Affairs confirmed the above-named Order.


The effect of the Order as confirmed is to divert that part of Public Footpath Number 2 in the parish of Tallington running from OSGR TF 0975 0846 (D) in a generally east north easterly direction for approximately 444 metres to terminate at OSGR TF 1016 0861 (P). The total length of footpath to be diverted to be approximately 444 metres as shown between points D-P on order drawing numbered 2012/011/PPO299/A3 TO AN ALTERNATIVE ROUTE in the parish of Tallington to be 2 metres in width running from OSGR TF 0990 0834 (M) in a generally north easterly direction for approximately 375 metres to OSGR TF 1017 0859 (Q) then continuing in a generally north westerly direction for approximately 27 metres to terminate at OSGR TF 1016 0861 (P). The total length of footpath to be added to be approximately 402 metres as shown between points M-Q-P on order drawing numbered 2012/011/PPO299/A3. Limitations and Conditions: 1 No. Handgate to be provided at OSGR TF 1017 0859. Width 1.2 metres.

The Order comes into force as from 13 November 2024 but if a person aggrieved by the Order desires to question its validity, or of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within six weeks from 8 November 2024 make an application to the High Court.
